Filing category: Briefs/appendices

Event	Used when
Addendum FILED	A party files a separately bound volume of statutes, rules, or regulations.
Anders Brief FILED	Appellant's counsel files a brief pursuant to <i>Anders v. California,</i> 386 U.S. 738 (1967).
Appellant/Petitioner Brief & Appendix FILED	Appellant/Petitioner files a principal brief with an appendix attached.
Appellant/Petitioner Brief & Special Appendix FILED	Appellant/Petitioner files a principal brief with a special appendix (containing appealable order, rules, statutes, and regulations) attached.
Appellant/Petitioner Brief FILED	Appellant/Petitioner files a principal brief with no appendix attached.
Appellant/Petitioner Final Form Brief FILED	Appellant/Petitioner files a final form principal brief after having filed a page proof version of the brief as permitted under FRAP 30(c).
Appellant/Petitioner Final Form Reply Brief FILED	Appellant/Petitioner files a final form reply brief after having filed a page proof version of the reply brief as permitted under FRAP 30(c).
Appellant/Petitioner Page Proof Brief FILED	Appellant/Petitioner files a page proof version of the principal brief as permitted by FRAP 30(c).
Appellant/Petitioner Page Proof Reply Brief FILED	Appellant/Petitioner files a page proof version of the reply brief as permitted under FRAP 30(c).
Appellant/Petitioner Reply Brief FILED	Appellant/Petitioner files a reply brief in response to appellee's/respondent's principal brief.
Appellee/Respondent Brief & Appendix FILED	Appellee/Respondent files a principal brief with an appendix attached.
Appellee/Respondent Brief FILED	Appellee/Respondent files a principal brief with no appendix attached.

Event	Used when
Appellee/Respondent Final Form Brief FILED	Appellee/Respondent files a final form principal brief after having filed a page proof version of the brief as permitted by FRAP 30(c).
Appellee/Respondent Final Form Reply Brief FILED	Appellee/Respondent files a final form brief in response to appellant's final form reply brief in a cross appeal and as permitted by FRAP 30(c).
Appellee/Respondent Page Proof Brief FILED	Appellee/Respondent files a page proof version of the principal brief as permitted by FRAP $30(c)$.
Appellee/Respondent Page Proof Reply Brief FILED	Appellee/Respondent files a page proof version of the reply brief as permitted under FRAP 30(c).
Appellee/Respondent Reply Brief FILED	Appellee/Respondent files a brief in response to appellant's reply brief in a cross-appeal.
Appendix FILED	Appellant/Petitioner files an appendix or joint appendix. The event has a drop-down for Appellant to select whether or not a joint appendix is being filed.
Corrected Appendix FILED	A party files a corrected version of a previously filed joint appendix or appendix after the filer discovers an error or errors in the previously filed appendix. Do not use this event to submit a corrected version of the appendix pursuant to a court-issued defective filing notice. Instead, select the Appendix FILED event.
Corrected Brief FILED	A party files a corrected version of a previously filed brief after the filer discovers errors in the previously filed brief. Do not use this event to submit a corrected version of the brief pursuant to a court-issued defective filing notice. Instead, select the proper event used for filing the brief in the first instance.
Deferred Appendix FILED	A party files a deferred appendix permitted by stipulation or Court order under FRAP $30(c)$ an LR $30.1(c)$.
Designated Counsel Brief FILED	A counsel designated by this Court to advocate for a particular party or position files a principal brief.

Event	Used when
Designated Counsel Reply Brief FILED	A counsel designated by this Court to advocate for a particular party or position files a reply brief in response to another party's brief.
Exhibits FILED	A party files a separately bound volume of reproduced exhibits.
Intervenor Brief FILED	An Intervenor party files a brief in response to a party's principal brief as permitted by the Court.
Intervenor Reply Brief FILED	An Intervenor party files a reply brief response to a party's principal brief as permitted by the Court.
Memorandum Brief FILED	A party files an informal brief, in the form of a written note or outline, of a particular legal argument.
Post-Argument Brief FILED	A party files court-ordered brief after the appeal has been heard.
Post-Argument Letter Brief FILED	A party files a court-ordered brief in letter format after the appeal has been heard.
Special Appendix FILED	A party files a separately bound appendix containing the appealable order, rules, statutes, and regulations.
Supplemental Appendix FILED	A party files a subsequent or additional appendix when ordered by the Court, submitted by a Government appellee in a CJA case, or submitted in a prisoner case.
Supplemental Brief FILED	A party files a court-ordered brief after its principal brief has been filed.

Filing category: Correspondence/forms/letters

Event	Used when
Acknowledgment and Notice of Appearance FILED	A party files an acknowledgment and notice of appearance.
Amended/Corrected Form FILED	A party files a Court form (e.g., Forms B, C, D, or acknowledgment and notice of appearance) with amended information.
Certificate of Service FILED	A party files a certificate of service served on a non-ECF party.
Certified List FILED	A federal agency files a list describing all documents, transcripts of testimony, exhibits, and other materials constituting the record on appeal.
Designation/Cross Designation FILED	The appellant or appellee files a list identifying documents from the original record to be utilized on appeal.
FORM B FILED	Counsel or a pro se party to a criminal appeal files Form B.
FORM C FILED	Counsel in a civil appeal files Form C.
FORM C/A FILED	Counsel in an agency appeal files Form C-A.
FORM D FILED	Counsel in a civil case files Form D.
Form D-P FILED	A pro se with electronic filing privileges files Form D-P.
FRAP 10(b)(3)(A) Statement of Issues FILED	Appellant files a statement of the issues appellant intends to present on appeal under FRAP $10(b)(3)(A)$.
FRAP 26.1 Corporate Disclosure Statement FILED	Counsel files the corporate disclosure statement required by FRAP 26.1 .
FRAP 28(j) Letter RECEIVED	Counsel or a pro se party files a letter under FRAP 28(j) to alert the Court of additional pertinent and significant authorities not cited in a previously filed brief.

Correspondence/forms/letters, cont'd

Event	Used when
Letter RECEIVED	Counsel or a pro se party files a letter other than a letter regarding the status of record on appeal, a scheduling notification letter under LR 31.2, a stay status update letter under LR 42.1, or a transcript status update letter under LR 11.3(c).
LR 32.1 Scheduling Notification RECEIVED	Counsel or a pro se party files a letter informing the Court of the proposed filing date of a principal brief.
LR 46.1(e) Form FILED	A supervising attorney files an appearance for an eligible law student who will be participating in a case.
Notice of Appearance for Additional or Substitute Counsel FILED	Counsel files the required form to enter an appearance as additional counsel in a case or to enter an appearance as new lead counsel to replace previous counsel.
Notice of Hearing Date Acknowledgment FILED	Counsel or a pro se party files confirmation of receipt of a hearing date notice.
ORAL ARGUMENT Statement LR 34.1 (as) FILED	Counsel or a pro se party files the oral argument statement required under LR 34.1.
ROA Status Update Letter RECEIVED	Counsel or a pro se party files a letter informing the Court of the status of an outstanding record on appeal.
Stay Status Update Letter RECEIVED	Counsel files a letter informing the Court of the status of lower court or agency proceedings staying the appeal.
Transcript Status Update Letter RECEIVED	Counsel or a pro se party files a letter informing the Court of the status of completion of lower court transcript(s).

Filing category: Application, motion, petition for rehearing, support, opposition

Event	Used when
Answer to Application or Cross Application for Enforcement FILED	Petitioner files an answer to an application for enforcement or respondent files an answer to a cross-application for enforcement.
Itemized Bills of costs FILED	A party files a bill of costs after the Court has entered judgment.
Motion FILED	A party or non-party moves for relief by the Court in a docketed case. When selecting the event, the filer must choose the appropriate relief(s). When the requested relief is not listed, choose "for relief." See the list of reliefs here.
NLRB Reply to Answer FILED	NLRB counsel files a reply to the answer to an application for enforcement.
Non-opposition response FILED	The Government files a response to a motion it does not oppose.
Opposition FILED	A party files an opposition to a motion.
Petition for Rehearing FILED	Counsel or a pro se party files a petition for rehearing without an accompanying petition for rehearing en banc.
Petition for Rehearing/Rehearing En Banc FILED	Counsel or a pro se party files a petition for rehearing en banc either on its own or with a petition for rehearing.
REPLY to Opposition FILED	A party files a reply to opposition papers to a motion.
RESPONSE to Show Cause FILED	Counsel or a pro se party files a response to an order to show cause issued by the Court.
Supplementary Papers FILED	Submitting documents to support a previous filing, or as ordered by the Court. Do not use this event to submit a memorandum of law in support of or in opposition to a motion. The memorandum of law must be uploaded as a separate attachment to the filed motion or opposition.

Filing category: Stipulations

Event	Used when
FRAP 42(b) Stipulation with Prejudice RECEIVED	Counsel files a stipulation by all parties consenting to withdraw and dispose the appeal with no intent to reinstate.
LR 42.1 Stipulation Status Update RECEIVED	Counsel files a stipulation on consent of all parties to extend the time to reinstate the appeal after the date the Court has so-ordered a LR 42.1 stipulation without prejudice to reinstatement.
LR 42.1 Stipulation without Prejudice RECEIVED	Counsel files a stipulation by all parties to withdraw the appeal temporarily with the possible intent to reinstate.
Non-dispositive Stipulation RECEIVED	Parties file a stipulation on consent as to a non-dispositive aspect of the case (e.g., a stipulation to file a deferred appendix).
Remand Stipulation RECEIVED	Counsel files a stipulation consenting to have the appeal remanded to the lower court or originating agency.
Transfer Stipulation RECEIVED	Counsel files a stipulation consenting to have the appeal assigned to a different court or agency.

Filing category: Non-party filings

Event	Used when
Amicus Brief on Consent FILED	Amicus counsel files a brief with the consent of all parties to the appeal.
Amicus Brief upon Court Order FILED	Amicus counsel files a brief after obtaining the Court's permission.
Motion for Leave to File as Amicus FILED	Amicus Counsel files a motion for leave to file a brief when counsel has not obtained consent from all the appellate parties. Movant must include the proposed amicus brief as an exhibit.
Motion to Intervene FILED	Counsel for a non-party files a motion to become part of the appeal to protect the non-party's interest in the matter.
Notice of Appearance for Amicus Counsel FILED	Amicus counsel files the requisite notice of appearance upon filing its brief either by consent of all parties or upon Court approval. This document must be filed in conjunction with the filing of the amicus brief.

Filing category: EOIR Immigration Record on Appeal

Event	Used when
ROA FILED	A federal agency, in immigration appeals, files the administrative record on appeal.
